General

These terms and conditions are non-negotiable and do not require a response. By submitting a Stage 1 Application for Funding (each a "Stage 1 Application") each applicant confirms that these terms and conditions are accepted without reservation.

The One Billion Trees Fund is a government initiative which is administered by Te Uru Rākau, a unit within the Ministry for Primary Industries. Any reference to Te Uru Rākau in these terms and conditions, is a reference to MPI on behalf of the Crown.

Reliance by Te Uru Rākau

Te Uru Rākau may rely upon all statements made by any applicant in a Stage 1 Application and in correspondence or negotiations with Te Uru Rākau or its representatives.

Each applicant must ensure all information provided to Te Uru Rākau is accurate. Te Uru Rākau is under no obligation to check any Stage 1 Application for errors, omissions, or inaccuracies. Each applicant will notify Te Uru Rākau promptly upon becoming aware of any errors, omissions, or inaccuracies in its Stage 1 Application or in any additional information provided by the applicant.

Confidentiality and Consent

Each applicant consents to the use of the information contained in the Stage 1 Application by Te Uru Rākau for the purposes of assessing that Application. Each applicant acknowledges that any hard copy Stage 1 Application or documentation supplied to Te Uru Rākau may not be returned.

Te Uru Rākau is bound by the Official Information Act 1982 ("OIA"), the Privacy Act 1993, parliamentary and constitutional convention and any other obligations imposed by law. While Te Uru Rākau intends to treat information in Stage 1 Applications as confidential to ensure fairness for applicants during the assessment and decision making process, the information can be requested by third parties and Te Uru Rākau must provide that information if required by law. If Te Uru Rākau receives an OIA request that relates to information in this Stage 1 Application, where possible, Te Uru Rākau will consult with you and may ask you to confirm whether the information is considered by you to be confidential or still commercially sensitive, and if so, to explain why.

Limitation of Advice

Any advice given by Te Uru Rākau, any other government agency, their officers, employees, advisers, other representatives, or the IAP about the content of your Stage 1 Application does not commit the decision maker (it may be senior officials, Ministers or Cabinet depending on the level of funding requested and the nature of the project) to make a decision about your Stage 1 Application.

This limitation includes individual members of the IAP. The IAP's recommendations and advice are made by the IAP in its formal sessions and any views expressed by individual members of the IAP outside of these do not commit the IAP to make any recommendation.

No contractual obligations created

No contract or other legal obligations arise between Te Uru Rākau and any applicant out of, or in relation to, the Stage 1 Application and assessment process.



No process contract

The Stage 1 Application and assessment process does not legally oblige or otherwise commit Te Uru Rākau to proceed with that process or to assess any particular applicant's Stage 1 Application, or enter into any negotiations or contractual arrangements with any applicant. For the avoidance of doubt, this Stage 1 Application and assessment process does not give rise to a process contract.

Costs and expenses

Te Uru Rākau is not responsible for any costs or expenses incurred by you in the preparation of a Stage 1 Application or subsequent application.

Exclusion of liability

Neither Te Uru Rākau or any other government agency, nor their officers, employees, advisers or other representatives, nor the IAP or its members will be liable (in contract or tort, including negligence, or otherwise) for any direct or indirect damage, expense, loss or cost (including legal costs) incurred or suffered by any applicant, its affiliates or other person in connection with this Stage 1 Application and assessment process, including without limitation:

- a) the assessment process
- b) the preparation of any Stage 1 Application or application
- c) any investigations of or by any applicant
- d) concluding any contract
- e) the acceptance or rejection of any Stage 1 Application, or
- f) any information given or not given to any applicant(s).

By participating in this Stage 1 Application and assessment process, each applicant waives any rights that it may have to make any claim against Te Uru Rākau. To the extent that legal relations between Te Uru Rākau and any applicant cannot be excluded as a matter of law, the liability of Te Uru Rākau is limited to \$1.

Nothing contained or implied in or arising out of the Stage 1 Application documentation or any other communications to any applicant shall be construed as legal, financial, or other advice of any kind.

Inducements

You must not directly or indirectly provide any form of inducement or reward to any IAP member, officer, employee, advisor, or other representative of Te Uru Rākau or any other government agency in connection with this Stage 1 Application and assessment process.

Governing law and jurisdiction

The Stage 1 Application and assessment process will be construed according to, and governed by, New Zealand law and you agree to submit to the exclusive jurisdiction of New Zealand courts in any dispute concerning your Stage 1 Application.

Te Uru Rākau asks applicants not to release any media statement or other information relating to the submission or approval of any Stage 1 Application to any public medium without prior agreement of Te Uru Rākau.
