 - You, as the game estate operator, wish to supply game estate animal material for processing as regulated product.

Read these notes before you start filling out the form:

- Listing of certain game estates with the Director-General of the Ministry for Primary Industries is required under section 65D of the Animal Products Act 1999.
- If it is intended that the animal material from the game estate be processed for export, your game estate will need to be verified by MPI Verification Services.
- An annual verification of your game estate is required to maintain your game estate listing.

Game Estate = A game estate is a place within which animals are kept (whether all of the time or only some of the time), as if in the wild, for the purpose of providing opportunities for persons to hunt or catch them as recreational catch as if in the wild, being animals of a species, kind, or description specified for the purposes of this section by notice under section 167.
