#### **Payment**

There is a fee for submitting this application if the land you are applying to remove is registered in standard forestry. There is currently no fee for applying to remove land from permanent forestry. However, land can only be removed from permanent forestry with approval from the Minister of Climate Change.

The fee for applying to remove part of one or more carbon accounting areas from standard forestry is \$1,072.50 (excluding GST). You will be required to pay this amount when you submit your application in Tupu-ake – Forestry ETS online services.

Your application will not be processed until this fee is paid.

## Option to deregister

#### How to submit your application

If you are applying to remove land from a carbon accounting area registered as standard forestry:

- 1. Log-in to Tupu-ake Forestry ETS online services, available at <a href="www.mpi.govt.nz/ets-online-system/">www.mpi.govt.nz/ets-online-system/</a>
- 2. Select the service Post-1989 forest land (standard) > Add, update or reconfigure forest land > Apply to remove parts of carbon accounting areas.
- 3. Upload the completed form and your shapefile to the file upload on the main summary page.

If you are applying to remove land from a carbon accounting area registered as permanent forestry:

- 1. Log-in to Tupu-ake Forestry ETS online services, available at <a href="www.mpi.govt.nz/ets-online-system/">www.mpi.govt.nz/ets-online-system/</a>
- 2. Select the service Post-1989 forest land (permanent) > Add, update or reconfigure forest land > Apply to remove parts of carbon accounting areas.
- 3. Upload the completed form and your shapefile to the file upload on the main summary page.

#### **Next steps**

After you remove land from one of more carbon accounting areas, you must submit an emissions return. We'll send you a link to complete your emissions return in the system. Tick to indicate how you want to complete your emissions return:

I want to do my own calculations and manually enter the values into the emissions return.

I want to use the system to complete the calculations and generate the values for the emissions return.

You may need to pay (surrender) units for the forest land you remove. The Environmental Protection Authority will contact you with instructions and how many units you must pay.

However, you don't need to pay units if you remove land because:

- · a natural event has happened that permanently prevents the re-establishment of the forest (for example, a river has eroded the land), or
- the land has been cleared for Best Practice Forest Management (for example, to comply with National Environmental Standards for Commercial Forestry).

If you have selected either of these reasons, we will complete checks to verify it.
