4 Participant's NZETR holding account number

The Participant must have an open holding account at the New Zealand Emissions Trading Register (NZETR) from which NZUs can be surrendered to meet deforestation liabilities. The Registrar of the NZETR allocates a preliminary holding account number and this notification may continue to be processed while a holding account is being opened, but no NZUs can be transferred to meet liabilities until the holding account is fully open.

The **account holder names** of the holding account must be **identical** to the full legal names of the persons entered into section 2 above, except where the Participant is:

- an unincorporated body (the account holder name(s) must match the unincorporated body members listed in section 3); or
- part of a consolidated group (in this case the group's holding account number and names should be used).
