1.2 Scope

The requirements listed in this Importing Country's Phytosanitary Requirement (ICPR) document apply to product of New Zealand only, unless specifically stated.

This ICPR specifies Myanmar's phytosanitary requirements. If a commodity or commodity group is not identified within this ICPR exporters should direct enquiries to:

- Myanmar directly to ascertain requirements
- or
- Ministry for Primary Industries (MPI)-Plant Exports. Refer to 1.1

1.3 Phytosanitary legislation

The following legislation controls the importation of plants and plant materials into Myanmar:

- The Plant Pest Quarantine Law for the State Law and Order Restoration Council

1.4 Fees and charges

- Please note that the determination and provision of phytosanitary requirements for a commodity not listed within the ICPR may be undertaken on a cost recovered basis. 2 General Requirements

2.1 Definitions

Table 1. Definitions defined by the Plant Pest Quarantine Law.

Beneficial Organism	An organism which benefits the agriculture by causing disease to/parasitizing eggs or by predateding the pest. This includes insects, arachnids, fungi, bacteria, viruses, nematodes and various kinds of edible mushrooms which in one way or another benefit agriculture and other organisms, as prescribed by the Myanmar Agriculture Service.
Import Certificate	The certificate issued by the Myanmar Agriculture Service for the purpose of importing plant, plant product, pest, beneficial organism or soil. In New Zealand this certificate is also known as an import permit.
Managing Director	The Managing Director of the Myanmar Agriculture Service.
Minister	The Minister for the Ministry of Agriculture.
Ministry	The Ministry of Agriculture.
Non-plant Product	Any material which is not a product of plant and which is contaminated with pest constituting risk of spread. This includes imported materials which have been prescribed for the purpose of this Law by the Ministry for inspection.
Pest	Insects, arachnids, rats, moles, snails, weeds that destroy crops, food or commodities or those interfering with human beings or animals. This also includes other pests that cause plant disease and living organisms prescribed by the Myanmar Agriculture Service.
Phytosanitary Certificate	An internationally recognized certificate issued by the Myanmar Agriculture Service after phytosanitary inspection in accordance with the model prescribed in the 1951 International Plant Protection Convention.
Plant	The cultivable plant and propagative parts thereof. Includes seed, tuber, corn, bulb, root or stem part of the plant.
Plant Product	Any unprocessed material of plant origin or even though processed which by the nature and that of the processing method may create a risk for the spread of pests. Includes tuber, corn, bulb, grain, fruit or vegetable for consumption.
Quarantine Pest	A pest dangerous to plants, but not yet in existence in Myanmar and even those in existence but not widely spread, yet needs to be controlled.
Transit Camp	A camp being stationed for the purpose of temporary storage of plant, plant product, pest, beneficial organism or soil from the arriving carrier to Myanmar, before being transferred to the outgoing carrier destined to any foreign country.

2.2 Prohibitions

Commodities not listed in section 4 are prohibited.

2.3 Import Permits

Import permits are required for all commodities. An import permit is also referred to as “import certificate” in Myanmar.

From 1 October 2017, Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

2.4 Phytosanitary Certificates

All exported commodities must be accompanied by a phytosanitary certificate.

2.5 Pest Risk Analysis (PRA) Requirements

Myanmar have clarified their requirements for Pest Risk Analysis (PRA) information for new Market Access and for historic trade of fresh produce, nursery stock and seeds for sowing (note that data is not required for frozen produce).

Please be advised that for any new market access crop/commodity requests Myanmar require data to enable their PRA. Myanmar will not allow import of the new crop/commodities from 1 January 2017.

For crop/commodities that have been accepted as existing trade Myanmar still need to undertake a PRA. Seeds for sowing must supply PRA information to MPI by 28 February 2018 and for fresh produce, by 30 June 2017.

2.6 Inspection on Arrival

- All consignments of plant and plant products may be subject to inspection on arrival.
- If quarantine pests are found during inspect, the Myanmar Agriculture Service has the right to carry out disinfestation or disinfection treatment at the cost of the exporter.

2.7 Sampling Rate

Not specified by Myanmar.

2.8 Ports of Entry

- Yangon International Airport
- Yangon Port
- Myanmar Posts and Telecommunications, Foreign Mail Service
- Transit Camp

The ministry may extend the establishment of pest inspection camps.

2.9 Transit Requirements

- All consignments must be accompanied by a phytosanitary certificate and import permit.
- The transit requirement is subject to all import regulations of Myanmar.

3 Commodity Class Requirements

3.1 Fruit and Vegetables

3.1.1 Fresh Fruit

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.1.1 for fresh fruits specific commodity requirements. Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

The following additional declaration may be used to meet import permit requirements for the disinfection treatment of fresh fruit for Queensland fruit fly (*Bactrocera tryoni*) and Mediterranean fruit fly (*Ceratitis capitata*):

Additional declaration:

“New Zealand is free from *Bactrocera tryoni* and *Ceratitis capitata*.”

3.2 Cut Flowers and Foliage

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.2 for specific commodity requirements. Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

3.3 Nursery Stock

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.3 for specific commodity requirements. Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

3.4 Seeds, Grains and Nuts

3.4.1 Seeds, Grains and Nuts for Sowing

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.4.1 for specific commodity requirements. Myanmar requires that the four digit import

certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

3.4.2 Seeds, Grains and Nuts for Consumption

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.4.2 for specific commodity requirements. Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.

3.4.3 Seeds, Grains and Nuts for Processing

Conditions:

Import permit required. Phytosanitary certificate required. Refer to Section 4.4.3 for specific commodity requirements. Myanmar requires that the four digit import certificate/permit number be stated in the additional declaration section of the phytosanitary certificate.
