	The Ministry for Primary Industries (MPI) has amended the <i>Import Health Standard for Zoo Asian Elephants from Australia and Sri Lanka</i> . The amended standard allows for zoo Asian elephants to be imported directly from Sri Lanka following extended quarantine and testing without the requirement for quarantine in an FMD-free country.
