

**OFFICIAL INFORMATION ACT REQUEST**

Further to our letter on 26 November 2014 and payment from you received on 26 February 2015, please find attached the correspondence relating to the Kaimaumu Road property as requested.

The requested files are provided to you in two files. The first file contains correspondence organised chronologically with the most recent items first. Please note that in the email dated 13 Feb 2012 2:08pm, in paragraph three the author states "I have sought legal advice." This is incorrect and it should have read "I have sought technical advice."

The second file contains packing slips that were provided to MPI.

MPI has decided to withhold certain portions of the information under section 9(2)(a) of the Official Information Act (OIA) 1982 to protect the privacy of natural persons; section 9(2)(g)(i) to protect the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty; and section 9(2)(h) to maintain legal professional privilege.

MPI is satisfied that in the circumstances of this case, the withholding of this information is not outweighed by other considerations which render it desirable in the public interest to make the information available.

You have the right under section 28(3) of the Official Information Act to seek an investigation and review by the Ombudsman of our decision to withhold information.

- maps of the areas targeted for excavation going forward.
- a record of logs removed with diameter at ground height and volume, s 9(2)(a) on a visit undertaken by s 9(2)(a) and myself we spoke about this requirement which you had already been doing independantly, could you scan and send through what you have. As explained then this is a new requirement been imposed on all swamp kauri operators as we require some tracability from source to to destination particularly when indigenous timber is destined to be exported as stump material (as per the Forest Act 1949 s67C(1)(d)).

s 9(2)(a) have asked me to respond to your email below. My comments reflect our earlier discussion. The situation as to the legality of kauri log extraction from the Sovereign Station Property is as follows:

1. My clients have obtained a resource consent from FNDC of December 2011. That approval includes a plan showing are area of the property where extraction can occur. No further consent is required from FNDC for extraction work within that area. You already have that consent.
2. Extraction within a Significant Indigenous Wetland (as defined under the Regional Water and Soil Plan) would require a resource consent from NRC. However, the area shown on the FNDC approved plan has been agreed by NRC as not being a Significant Indigenous Wetland and therefore extraction in that area is a permitted activity according to NRC. As such, no approval is required from them.
3. The Enforcement Order does not prevent permitted activities under the Regional Plan occurring – such as this.
4. Drawing the strands together, extraction of logs and stumps from the FNDC approved area are is legal and consented. I understand NRC have confirmed this to you directly themselves. Frankly, this is the understanding you should have been left with last week.
5. s 9(2)(a) will provide you with their application directly.

I trust this clarifies the position for you. Please confirm.

I apologise for the delay in forwarding on the milling statement application, however I needed to be convinced I was acting appropriately under the intent and word of the Forests Act 1949. Therefore you should know that information and requests presented in this email have not been made independently without sound advice.

Attached is the milling statement application form which needs to be completed prior to any further milling of indigenous timber taking place.

For your information, I have looked up the enforcement order dated 1 September 2011. The enforcement order applies to the entire property for which the original milling statement was issued (Identifier: 421080, Legal description lots 5 - 7 DP 405064). In regards to this enforcement order I have sought legal advice as to a Forestry Officers responsibilities when issuing milling statements. While a milling statement does not confer right, title or ownership to the timber and states that prior to harvesting any resource consent/compliance requirements should be satisfied. This is consistent with the Forests Act 67v that states; "Nothing in this part derogates from any provision of the Resource Mangement Act 1991". Therefore I have been advised it would be irresponsible for a Forestry Officer to issue a milling statement under this circumstance.

Further to this, on my original inspection of the excavation site on the 17th October 2011, I did not become fully aware of the complexity of the vegetation type and land classes throughout the property. While the area I viewed during the initial inspection was exotic, there have been areas excavated that I have viewed in subsequent inspections that may be considered indigenous land. This variation in land class is consistant with the report prepared by Wildlands Consultants (February 2011); sections 6.3.1, 6.3.2 and 6.3.3.

Therefore the requirements for a milling statement application to be approved are; proof that the enforcement order issued by the environment court does not apply to the property or the operation in question or proof that the enforcement order has been withdrawn. Further to this we require confirmation that land from where stumps and logs are excavated is from non indigenous land. This may be done by mapping areas targeted for excavation.

I realise these requirements may impede the progress of your operation however it is required in order to be consistant with the Forests Act 1949 and thus consistant with the requirements placed on other parties involved in similar operations.

For clarity; As far as I am aware s 9(2)(a) has not been in contact with the Northern Environmental Protection Agency.

Referring to our discussion and site meeting of Friday afternoon.

It seems you do not want to renew our milling statement for ancient kauri logs. You advise that of the Northland Regional Council has been speaking to you about our milling statement and he does not want you to issue us with a new milling statement. He says that we have a enforcement order that stops us from extracting ancient kauri stumps and logs and that we should not be working on the Sovereign Station property.

has told you that we are extracting kauri stumps and logs illegally.

As we discussed on site, there is no issue at all with these logs. We have a resource consent from FNDC for Sovereign Station Trustee Limited (attached) over part of the site.

Extraction in this part of the property is also a permitted activity under the NRC rules and does not require a resource consent. We applied for a certificate confirming this from the NRC and they were going to issue it, but we withdrew it because we could not talk to s 9(2)(a) about it. So these logs and stumps have been extracted totally legally and both councils are satisfied.

You said that we could apply for a new milling statement today, which we need urgently.

You also mentioned that s 9(2)(a) had been in touch with the Forest Protection Services down in Whangarei. We are really concerned that s 9(2)(a) is causing trouble for us and lots of other people, and I really don't see why you need to go back and talk to him about this again after Friday. Our milling statement is nothing to do with NRC or him.

Please ring and let me know you have all this and that everything is in order.

We wish to advise you that Milling Statement 7-00-01480 which provides for the milling of salvage swamp kauri from s 9(2)(a) Kaimaumu property expired on 17/01/2012. Any milling since this date of any logs or timber recovered from this property would be an offence against the Forests Act 1949 – even if it was excavated prior to the expiration date.

was given notice of the inspection on the afternoon of the 1-12-2011. He said he would be onsite. At 1200 hours the following day let know I 9(2)(a)
would be arriving onsite at around 13:00 hours. He said he would not be able to make it onsite but the gate should be open and to head on in. The gate was closed when I arrived at 13:00 so I continued on foot.

I found the areas that had been excavated had encroached on land could be considered indigenous flora and was not the farmland originally indicated on a previous inspection as the class of land that would be excavated. There was very little remnants of vegetation that existed prior to excavation therefore areas adjacent to excavation sites were assessed. These contained mixed manuka/kanuka/acacia spp (i.e. mixed indigenous/exotic) some areas predominantly acacia and some predominantly manuka kanuka. There were areas that appeared ready for cultivation with very little or no evidence of kauri salvage.

I spoke to subsequent to my inspection and let him know he was pushing the boundaries of the Forests Act in regard to excavation in indigenous land. He said he would get the operators to pull back into the acacia. Another inspection is required to ensure the operators are restricting their activities to non indigenous land.

On 17-10-2011 I met with a person I know as I met with on what I believed to be his property; Lot 5 Deposited Plan 405064. s 9(2)(a) had begun extraction of swamp Kauri logs from his property and wanted to begin milling the extracted logs. s 9(2)(a) stated that he would be milling the timber on his own mill located at ITM Mangonui, a property managed by associate The mill is a MAF registered mill; mill registration number 00/0120/1117. 9(2)(a)

I looked at the property I believed to belong to but I now think may be the neighbouring property of and I saw that it was predominantly ^{exotic} pasture. I asked s 9(2)(a) if this was the same class of land that all the Kauri had been extracted from they said yes but there was another site on the same property which they were still trying to get resource consent in order to extract kauri. I stated in order to get a milling statement any land from where the Kauri is extracted must not contain predominantly indigenous flora and explained that indigenous includes Manuka and Kanuka shrubland. stated that it was predominantly Acacia to which I replied if that is the case then it would be ok to get a milling statement for the extracted logs. This discussion was witnessed by Forestry Officer s 9(2)(a)

On 18 October 2011 I issued an "Indigenous Timber Milling Statement," No. 7-00-01480, pursuant to the Act allowing to mill kauri originating from his property located at s 9(2)(a) Kaimaumau Road, Kaimaumau." Refer appendix 1. The milling statement allowed s 9(2)(a) to mill 1,000 cubic metres of

roundwood (not sawn) indigenous timber, namely Kauri, in the period 18 October 2011 to 17 January 2012. As discussed, the milling statement required the timber to be sourced from within the address, from land that was not indigenous forest land.

I can confirm there has never been a milling statement issued for the neighbouring property.

Everything in above statement is true to the best of my knowledge and belief. It has been made by me knowing that it may be admitted as evidence for the purposes of the standard committal or at a committal hearing, and that I could be prosecuted for perjury if the statement is known by me to be false and intended by me to mislead.
