## OFFICIAL INFORMATION ACT REQUEST:

I refer to your official information request of 25 August 2014, requesting the following information:

- 1. Copies of photos taken of "carved temple poles" included in the Notice of Intention to Export application AK490.
- 2. Copies of photos taken of "monumental temple poles" included in the Notice of Intention to Export application AK484.
- 3. All emails, reports or notes held by MPI in relation to the inspection of the products listed above.

The following information is released to you under the Official Information Act 1982

 Copies of photos (examples of temple poles carved in China) provided by Ancient Kauri Kingdom Limited (AKK) top on 2 November 2010, as part of the Notice of Intention to Export application AK484.

Emails relating to the decision to decline application AK484, which was for export of temple poles in an un-carved state – which could not be considered a finished product.

- An inspection report for application AK490 dated 14 December 2010, together with copies of images taken during that inspection of the temple poles proposed for export to China.
- Emails relating to the decision to decline application AK490, given the lack of any evidence that the carving on the proposed temple poles was appropriate for any installation as a finished product in China.

Information has been withheld under the following sections of the Official Information Act;

- Section 9(2)(a) to protect the privacy of natural persons, including that of deceased natural persons.
- Section 9(2)(h) to maintain legal professional privilege
- Section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty.

You have the right under section 28(3) of the Official Information Act to seek an investigation and review by the Ombudsman of our decision to withhold information. A request must be made in writing to:

We note that exporters of wood products that are satisfied their products fully comply with the definition of a "finished or manufactured indigenous wood product" under the Forests Act 1949 do not actually need to apply to MPI for approval to export. Many do so voluntarily however, to avoid any possibility of later legal complications – knowing that just prior to export, the products are always inspected by a warranted forestry officer (either an MPI staff member, or staff of MPI's delegated agent Astre Quality).

My comments on the two issues, export and groundline, are:

1. Export of Finished Products

If the examples in the phiotos are destined for the Auckland market then we don't strictly need to make any judgement on them.

However we need to provide something to

My view is that two of the three examples in the first 3 photographs could be regarded as finished products if for instance they were being exported to be installed in "exactly" their present state for installation on foundations in front of a marae.

If they were being exported to a gallery for sale then you will have to make a call given the adequacy of the information available - e.g. invoices or consignment orders / addresses for the purchaser, similar to those we regularly saw on Ashfords spinning wheel kitsets (MFM3's) before they became exempt from the notification requirements, as finished products, etc. /

He must be told though that if MAF Asurequality believes that any specific example has been modified to be exported but it's real destination would seem likely to be a sawmill, then that will pose an issue.

I think you will need to chaft some guidance notes for Asurequality relating to both the Act and it's interpretation and what kinds of supporting information would be suitable. I am happy to help with that but it may have to wait for the New Year to be finalised

Acceptance of any temple pole as a finished product will be on an individual case by case basis.

Given that the stated purpose of the poles all along has been as Chinese Temple Poles, I wouldn't accept the latest carved examples submitted photographically to us by in an email on 7 December, given that they are not finished in my view and further, one has a very ethnic NZ carving on it.

6. Determining Some Kind of Benchmank

The visit by on 13 December to view a number of pieces in the company of AsureQuality will be helpfur in further defining what will constitute a finished product.

I can only suggest that officers must.

- 1. Be satisfied that the product (in this case temple pole) is manufactured into it's final shape and form; and
- 2. And is ready to be installed or used for it's intended purpose, without the need for any further machining or other modification.
- AMY subsequent carving or trimming would be further machining / modification.
- If they go to a supply company, this introduces a further level of uncertainty in my view, given that there will be no installation specifications for individual poles and so MAF will have to assume no further modification will take place WHEREVER the poles end up.


in essence MAF's position is as follows:

The Act defines a "finished or manufactured indigenous timber product" as:

(a) ...any indigenous wood product that has been manufactured into its final shape and form and is ready to be installed or used for its intended purpose without the need for any further machining or other modification; and

(b) Includes a complete item or a component of an item (whether assembled or in kitset form) such as joinery, furniture, toys, tools, and household utensils, household fixtures such as rails and toilet seats, ornaments such as picture frames and carvings, and similar items; but

(c) Does not include dressed or rough sawn timber, mouldings, panelling, furniture blanks, joinery blanks, building blanks, or similar items:

MAF has the view that the poles are indigenous timber, but they are not an "indigenous timber product". An indigenous timber product must be produced from indigenous timber and not be indigenous timber itself. Further, there needs to be some manufacturing process to convert the indigenous timber into a product. Also, given that the poles will be carved once they are placed on the site permanently, then they are not "finished" at the time they are exported.

In conclusion. MAF will be unable to sign off any MFM3 that includes timber for the above purpose that exceeds the length dimensions for stumps, as defined by the Act

I know this is not the answer you were seeking. However this is MAF's position at this time.

#### Greetings

I received a phone call yesterday from who advised me he will be submitting another MEM3 for approval. He will be undertaking a range of modifications to up to about 6 pieces, including some carving. He is determined to test MAF's interpretation of the export controls.

He does accept that unmodified swamp kauri are not finished / manufactured. He is now joing to test what "manufactured" constitutes.

I have told him any approval will ultimately rest with the Regional Manager but that MAF will continue to adopt a cautious approach, with if necessary legal advice on treatement of applications on a case by case basis.

I also advised him that because we have no assurance about the final location or use of the pieces since they are being purchased by a company for supply, this made it more difficult for MAF to adopt a more positive approach.

There will be no option but to inspect and form a position on this compliance or not with export controls.

The export of indigenous wood products from New Zealand requires the items meet criteria outlined in the Forests Act (1949).

Specifically, any wood product that is to be exported as a 'finished product' must be able to meet the definition as defined in the Act as follows:

Finished or manufactured indigenous timber product – Means any indigenous wood product that has been manufactured into its final shape and form and is ready to be installed or used for its intended purpose without the need for any further machining or other modification...)

The kauri logs that have been inspected at your factory which have been completed, or are in the process of being carved, at your factory will not satisfy this finished product definition.

The reasons for this view are as follows:

1. The stated intended end use will be as monumental temple poles in China.

MAF's view is that any pole used in such a context will in all likelihood be subject to further carving and modification (i.e. they are not in their final shape and form) to render them suitable for the cultural specifications of the purchaser.

No final destination and specification for the poles has been provided.

Without such information MAF cannot be satisfied that the poles are ready to be installed.

In order for MAF to be satisfied that the criteria for meeting a finished product have been satisfied, the exporter would need to provide evidence of the intended final user and that the poles met the purchaser's specified end use shape and form.

Clearly the export of logs is prohibited by the Forests Act. Any action to circumvent this prohibition or which may have the result of circumventing this prohibition is of concern to MAF. There will need to be a high level of confidence attached by MAF / Asurcquality to each and every finished product to satisfy this requirement of the Act. This means confidence that the item is completely finished, meets the purpose as stated and if necessary is supported by appropriate documentation so as to remove any

After meeting with Chinese interests in NZ, two millers of salvaged swamp kauri have approached MAF for clearance to export kauri "poles" as finished products. The purpose for their purchase is for supply as

monumental poles on religious sites, such as temples.

#### Background

Kauri is salvaged from non - indigenous forest land and timber stumps and roots may be exported, sawn or not, and as finished products. Stumps have a specific definition under the Forests Act.

The proposed monumental posts would generally not meet the stump length restriction/

The contention by the prospective exporter is that the poles are in their "final and finished form" and therefore are "finished products" and as such are eligible for export.

However they will be subject to further modification, such as carving

#### MY view

I have some misgivings about accepting such a product as a "finished product" upder the Forests Act.

To all intents this is akin to log export.

- The "poles" are being purchased by a supplier and could end up anywhere for any purpose;
- An approval to export kauri trunks for this purpose under the "finished product" category, could create a
  precedent for "log export" of any timber of any species from any source (forest or not), from any part of
  the country. From prior to Part 3A of the Porests Act (1993) indigenous log export has been
  specifically prohibited.

#### Request for Advice:

Would you please provide your views as to the classification of whole salvaged kauri stumps / trunks that exceed the "stump" length restriction, with the minimum of trimming, as finished products, where they are exported for supply by a third party of erection in an unmodified state.




